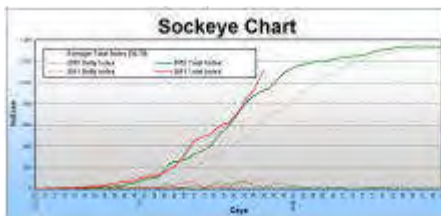
Tue January 31/12 5:10am

Skeena River:

Water is barely fishable. Some great Steelhead can still be had. Plus some good Trout Fishing. Lots of ice flow in the river now. Be careful walking on the ice near the edge of the river. **Reg:** all wild Steelhead everywhere in British Columbia are catch and release. I suggest the fishing rod be a [GLOomis STR 1265c/10'6"](#) MED-HEAVY Moderate Action (GL 2 8-17lb – 3/8 to 1 oz.). Reel [Shimano Calcutta \(400B\)](#) filled with 20lb test [Maxima](#) mono. [Gibbs](#) makes some great floats. Be sure to use a [Gamakatsu](#) hook. [Sockeye](#) fishing is great. **News:** The Sockeye run on the Skeena is predicted to be low this year but chart below shows an above average run has come-in so far. **Reg:** Sockeye limit: 2 per day. 0 per day from a boundary sign on the north bank of the Skeena River 100m upstream of the confluence with the Kitwanga River downstream to Mill Creek.

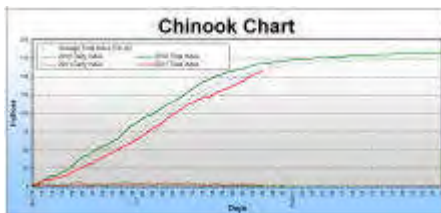

Kalum River:

A good run of Steelhead is in the river now. I have reports of some good catches. The upper end is in good shape. The lower end, due to rain, is starting to colour up. **How to:** This is a good river to float fish a Pink Worm or Goopy Bob. I suggest the fishing rod be a [GLoomis](#) STR 1265c/10'6" MED-HEAVY Moderate Action (GL 2 8-17lb – 3/8 to 1 oz.). Reel [Shimano](#) Calcutta (400B) filled with 20lb test [Maxima](#) mono. [Gibbs](#) makes some great floats. Be sure to use a [Gamakatsu](#) hook. **Fly fishing suggestion:** [Kamloops Dragon fly rod](#), [10' Kamloops fly reel](#), AFTMA #8line. Backing [Dragon Fly](#) "Bright Orange" 30lb, 150 yard spool. Fly line [SA Sharkskin](#) Steelhead WF-8-F.

Fishing report January 9th 2012



Hi Noel, We had a nice day fishing on the Kalum today. My wife Deanna caught several Dolly Varden and a Rainbow. I had one Steelhead on but it escaped before I could get it to the bank. Deanna was using a [3/16oz TM Croc spoon](#) and I was fishing a leach pattern fly on a sink tip with my 9wt. **Sage Z-axis** rod.

During our walk on the river we encountered a moose about 30 feet in front of us. It turned and swam through the middle of the pool we were about to fish. I snapped a couple photos as it reached the other side of the river. We are looking forward to our next day out.

The water is clean and fishing for Trout is excellent.

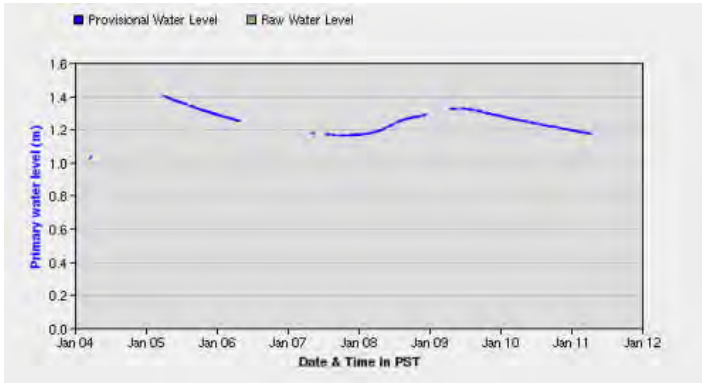
Sat January 21/11 5:10am

Water is low and in good shape but frozen over in some spots and ice flowing in the main current. Fishing for Steelhead was excellent before end of Dec 2011. Upper end is closed for fishing...to protect the wintering over Steelhead. **Facts:** Last year we had a record run of Steelhead, lets hope at least we have another good run this year. The fly rods work extremely well in this river. **Fly fishing suggestion:** [Kamloops Dragon fly rod](#), [10' Kamloops fly reel](#), AFTMA #8line. Backing [Dragon Fly](#) "Bright Orange" 30lb, 150 yard spool. Fly line [SA Sharkskin](#) Steelhead WF-8-F. **Where:** Sockeye fishermen are working the bars across from the Copper River. Fly fishing is the choice of many anglers on this river. Wading with quality [Simms](#) waders and accessories is the way to go. A friend of mine is very happy with his new [Islander](#) fly reel. [Trophy XL](#) fly rod, [Cortland Line](#) and [Maxima Tippet](#) . **Tip:** Fly fishermen please wade safely by using a wading staff. [Trophy XL](#) makes a nice one in 7 sections. Easily folds up and stores in a pouch on the waist.

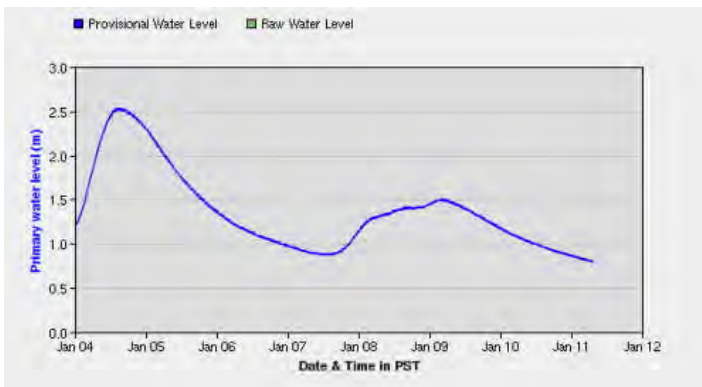

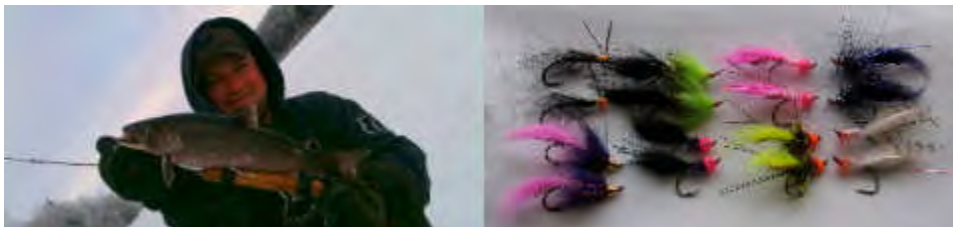

Great Pacific Adventure

There are many towns and cities across British Columbia that claim to be the salmon capital of the world but I'm not sure you'd find a place more deserving than Prince Rupert. This quaint little coastal town has been the hub of salmon fishing activity since the late 1800s when countless commercial canneries dotted the nearby shorelines. While a profitable commercial fishery still exists in the region, it's sport fishing now, however, that brings most fishermen to Prince Rupert. For some reason, I'd never fished this region so when SCI supporter, Jamie Hunt of Great



Pacific Salmon Lodge suggested we come up and check out his new lodge, Vanessa and I jumped at the opportunity. We managed to talk a few friends into joining us and Jamie gave us run of the lodge. We'd be his only guests for four days.

Vanessa and I arrived a day early which gave us the opportunity to check out the town and enjoy some of the local fare. Right

along the waterfront adjacent to our hotel was the Cow Bay Shopping District. This historic part of town offers a number of great shops and fabulous restaurants; the highlight of which was dinner at the Cow Bay Café. This tiny little restaurant is world renowned for their fusion cuisine and reservations are an absolute must. The town is also rife with totem poles and being real fans of these Native monuments, Vanessa and I took a few hours to go check them out. Many were brought over from Vancouver Island and the Queen Charlottes many years ago and they are unquestionably some of the most incredible totem



poles I've ever seen.

Spending a day in town was a great way to acclimate to the West Coast pace but we were ready to go fishing the following day. Great Pacific Salmon Lodge is the only lodge right in Prince Rupert. It is located on a sleepy little island directly across from town so despite Prince Rupert only being a few minute boat ride away, you still feel like you are in a wilderness setting. The lodge itself is a converted house and it offers all of the amenities, including a chef that offers up some of the most incredible West Coast cuisine. Jamie has a fleet of three well-appointed boats with guides and also offers a service for anglers wishing to utilize their own boats and fish on their own.

The first day found us heading north for a couple of hours and as we rounded the corner of a particularly rocky point, our guide, Matt Anderson, pointed to a steep rock wall. "We'll start there."

Matt worked quickly to set up a couple rods with cut-plug herring and in no time both downrigger cables were singing in the morning breeze. We were right at the tail end of the

Robin Rowland - Visual Journalism and Editorial

Robin Rowland, the editor and publisher of **Northwest Coast Energy News**, first encountered the northern British Columbia wilderness as a toddler on the shores of Ootsa Lake. After a short time in Vancouver, his family moved to Kitimat, where his father Fred, was the assistant property manager for Alcan. For the first two years, the family lived in the old Smeltersite (where from time to time his father would go fishing with others with Haisla guides on Douglas Channel and take the kid along). After that the Rowland family moved to main the Kitimat townsite. After seven years in Kitimat, the family moved to Toronto where Fred Rowland joined the development department of the booming city. Robin attended York University and then studied journalism at Carleton. He worked as a reporter photographer for the *Sudbury Star* and later was hired by CBC News, where he would work for most of his career (with gaps for travel, book writing and six years at CTV News). In 1996, he joined the new CBC news online division. In 1998, he was named web producer for The National and in 2003 became photo editor for CBC News. In 2010, Robin decided to take early retirement and return to northern British Columbia to pursue his interests in photography and writing.

Robin is co-author with James Dubro of *King of the Bootleggers*, about organized crime during the Prohibition era and a follow-up. *Undercover Cases of the RCMP's Most Secret Operative*. In 1995, Rowland co-wrote, with Dave Kinnaman, of Washington State, the first book on how to do research on the Internet. In 2000. Robin wrote *The Creative Guide to Research*. His latest book, published in 2008 is *A River Kwai Story: The Sonkrai Tribunal*.

He founded Northwest Coast Energy News in 2011 as an independent, neutral news website covering all aspects of the environmental and energy issues facing northwest British Columbia from the perspective of the northwest.

Robin also continues to freelance for major media, including CBC News and the Canadian Press picture service. As a freelance photographer he is available for editorial, wilderness and commercial assignments throughout the northwest region. His long term aim over the next couple of years is to launch a professional photo workshop business to bring more tourists to the northwest. Contact info:

The Vancouver environmental umbrella group, Ecojustice, a coalition of the Raincoast Conservation Foundation, the Living Oceans Society and Forest Ethics, has filed a motion with the Joint Review Panel calling into question the fairness of the hearings.

Within hours of the Ecojustice filing, the Prime Minister's Office issued an "InfoAlert," saying that it was Ecojustice who was interfering with the fairness of the Joint Review Hearings saying "Foreign radicals threaten further delays."

ISA virus - What a Mess

Hello

I spent the past few weeks pouring over the Cohen ISA virus hearings. That all the lawyers were called back for three days, speaks to the significance of ISA virus to BC. This hearing made it clear the salmon farming industry has grown beyond the control of government.

DFO is mandated to protect salmon, but when a virus concerns trade partners, the CFIA takes over. The CFIA has never heard of the Wild Salmon Policy.

DFO closed commercial fisheries to protect Cultus Lake sockeye. They have the power over us. 100% of the Cultus sockeye died just before spawning in 1999, 2000, 2001. When they were tested in 2002, 2003 - 100% were positive for ISA virus which is popping up everywhere there are salmon farms. DFO did nothing, no one breathed a word about this, not then, not now to this federal Commission into the fate of these sockeye and not ever to the First Nations of the Cultus Lake Region. It was a federal secret... why?

The CFIA said if the ISA virus is really in BC, markets could close permanently..... and this is the heart of the beast.

One of the strangest pieces of evidence was an internal CFIA email complaining that the Minister of Fisheries "may not understand that ISAV is no longer theirs." Undaunted the Minister's offices dictates precise, but inaccurate, wording for a letter to U.S. Senators that the "official" DFO lab has confirmed all ISAV tests were negative. But no one in the "official" lab actually said the tests were negative. Words like inconclusive and unconfirmed were used. We learned the machine the "official" lab uses is notorious for lack of sensitivity. We heard the scientists who did get positive results, found their reputations and labs threatened with ruin.

Dr. Jones, a DFO sea lice scientist, is inexplicably put in charge of the study that detected ISA virus in US and Canadian wild salmon in 2002/3 and he becomes the gate-keeper on that information. It would never have seen the light of day, if it were not for Dr. Kibenge. Dr. Miller a DFO researcher using cutting edge science, learns the hard way that "research must not fog policy" but she does not back down. Dr. Kibenge - one of two world reference labs for ISA virus thanks his university for fending off the attacks to his reputation, as a result of his diagnosis of ISA virus Pacific salmon. Dr. Nylund, present from Norway via video feed, just recently survived an industry "misconduct" attack for reporting that ISA virus traveled to Chile from Norway via farm salmon eggs.

The federal Minister of Fisheries describes independent reporting of ISA virus tests a needless risk to Canada's reputation. Really! That's pretty huge.

It looks like the whole problem is some deal out there where some country is paying for ISAV-free salmon and they might not be getting it. It is that simple.

Our governments can't afford to protect wild salmon in the face of global fish farm market pressures. I don't know exactly when this slipped out of their control, but my overall impression is WHAT A MESS. They have no idea what they are doing.

It is time for us to move on, we have been knocking on the wrong doors. It is not against the law for us to respect wild salmon and their health cannot be a federal secret anymore.

Dog quest 5

Perplexed and annoyed at my adolescent dog's habit of barking at shadows incessantly and relentlessly, I took her to Lou. Lou Alorza had a passion for angling in exotic locales. As we sat in one of the inner rooms of his Veterinary hospital, I examined the many photos of Lou and his fishing companions releasing large trout in what I guessed was Argentina or Chile.

What's the problem, Rob? Lou asked in a way that showed he was sincerely concerned. Then he listened intently as I described how Pawsome barked at shadows.

Lou's brow furrowed and moved his mouth in a way that made his handle bar moustache turn even farther up at one end.

Just a second, he said as he found a small flashlight then put my dog on the metal table. He turned off the overhead light and shone the flashlight into her eyes.

Look at this, he said.

I gazed into my dog's eyes. They were coated with milky clouds.

Cataracts, said Lou, his voice tinged with excitement at the discovery.

At the sound of the word, images of river water spilling over rock sprang into my mind. I could see how whoever coined the term cataract might have thought the milky opacity covering the lens of my dog's eyes resembled the white water behind river rock - and to the ancient eyes of whoever coined the term, that natural analogue must have seemed logical. To my 20th century orbs Pawsome's eyes more more closely resembled pictures of earth enveloped in white clouds taken from space.

Cataracts? I said. Aren't they an old folks' disease?

They can be congenital too, said Lou. Her vision is poor. She can't make out things distinctly.

Lou's diagnosis explained many of Pawsome's odd ball behaviours. Her barking was the natural reaction of her inability to identify motion, like the rattling of leaves and branches against the truck and the flickering of shadows against on the ground on bright days.

Getting Pawsome to behave on a leash was a task that would have taxed the most skilled trainer, but this wasn't a great concern to me. I had no intention of taking my dog into the woods on a leash. Paws' initial training consisted of walking the trails, and the places between the trails, on Terrace mountain from the

time she was so small I had to lift her over the logs. At this she shone, running just far enough ahead that I could only make out the white tip on her tail. Then, when she was straining against the invisible leash of her herding genes, she would unfailingly return to check up on my progress.

When I first took her to the river, it was at Shames. We walked down the creek from past the railway bridge then across the gravel beach to a spot where I could wade a back channel and make my way to the main river. I made the short, waist deep wade to the far side and turned. Pawsome was still at the water's edge attempting to parse the situation. She looked at me then tentatively touched the water with a paw, then she jumped in and swam across. From that point on she unhesitatingly followed me across rivers and streams. She didn't have the power of a retriever, but she was a strong swimmer, and except for one of her first outings, when she impetuously jumped into the river for no apparent reason and was swept under a log jam, and fortunately, popped up downstream a few anxious seconds later, she had no close calls.

When you fish salmon rivers, you need a dog that doesn't roll in the rotting salmon carcasses that wash up, or are pulled up, onto the banks late in the fall. When we encountered that situation, Pawsome showed no interest in rotting fish.

Porcupines are another challenge for dogs. Some dogs attack them, get a face full of quills, and learn to keep their distance after that, as Chimo did. Others swear a canine vendetta against Porkies after their initial encounter and take on every one they meet thereafter. Such dogs are a liability in bush and a strain on the wallet.

Again, partly due to her herding instincts, Pawsome sat on bank and kept an eye on me during fishing trips and showed no inclination to chase critters or their scents.

On several occasions, I managed to get lost. On every one of those debacles, I simply commanded Pawsome to go to the truck, and every time she did so as I followed, marvelling at her unerring accuracy.

Safety and survival on water:

A good set of Oars and Oar Locks is NOT just for Drift-Boaters:

The smartest thing you can do is install a good set of oars and oar locks in your jet-boat and learn how to use them. If your engine quits just snap in your oars and turn your jet boat into a drift boat and either row to shore or float to the boat launch. I have had to do this a few times myself when I was guiding. I've seen too many jet boats and all they have is puny paddles. One person with one paddle is useless and even two persons with two paddles are difficult to control a large or even a small jet boat. Throw those paddles away and get yourself a good set of oars and oar locks. **Do it now! It may save your life.** Drifting out of control into a sweeper, log jam or boulders is no fun. [Contact me anytime](#) and I will be happy to give you tips how to row your jet boat.

Attention Anglers Cold Water Kills:

The waters of British Columbia are cold year-round.

If you fall in the water, remember the 1 – 10 – 1 Principle

YOU HAVE:

- 1 minute to get your breathing under control;
- 10 minutes before you are too numb to hold on or to tread water effectively; and
- 1 hour before you become unconscious due to hypothermia.

PREVENT COLD WATER SHOCK:

- Always wear your lifejacket on board. Make sure it fits properly and is in good working order.
- Check the weather before departing.
- Don't overload your boat.
- Always tell someone where you are going and when you expect to return.

Over 90 percent of anglers who die while boating are not wearing a lifejacket. When you fall overboard, a lifejacket stored under your seat will do little to save your life.

Anglers are reminded to carry proof of competency such as a **Pleasure Craft Operator Card** on board at all times.

Do this to your life jackets NOW:

Sew on an elongated pocket on the back and near the bottom edge of all your life jackets. Have either a zipper or Velcro closer. The pocket should be clearly labelled with large letters:

SURVIVAL ITEMS ONLY

You should put the following items into the pocket:

- Silver space blanket
- Fire starter
- Water-proof matches/lighter
- Candle
- food/candy
- Pocket knife, etc

These items can be vacuumed packed so your pocket does not have to be water proof. Actually some drain holes in the bottom may be a good idea.

Anything that will help a person survive at least one night and not die of hypothermia is a good idea, I think.

Thank you and please be safe...

PS I have friends who almost died of hypothermia in a boating accident. Wearing their lifejackets saved them from drowning but the cold and damp almost did them in. They would have been more comfortable during the night if they had some survival items in their life jackets.
